Tidying up in advance

- Possibly an option now following COVID-19??
- If the Company has ceased
 - Close bank accounts, deregister for taxes etc.;
 - Make redundancies (if applicable)
 - If loans attached to property Stamp duty on loan element where asset distributed in specie – S.41 but can be avoided
 - SCSB structuring last three years wages;
 - Pension contributions
 - Getting rid of bad assets???
 - Plan in advance



Liquidations & Timing

- Possibilities of extracting cash on cessation of trade
- The reliefs available:
 - Section 598 TCA applies to liquidations
 - Watch if chargeable business assets are distributed dilutes relief
 - Options available
 - Concession if placed into liquidation within 6 months of cessation/sale of assets
 - Section 597AA Liquidations not in legislation;
 - Revenue concession Importance of when liquidator appointed
 - Excess cash Entrepreneurial relief vs retirement relief
 - If Sub Co. sold and Hold Co. liquidated No entrepreneurial relief



Liquidations & Tax

- Do the reliefs apply:
- Watch S.817 TCA and S.811C anti avoidance
- No stamp duty on liquidation BUT
 - How to structure to avoid stamp duty if loan attached to property/land;
 - Practically filing stamp duty return where property
- Ex-gratia payments/pension payments

Before Appointment

- Have an acceptance checklist See download;
- Do independence checks;
- Obtain AML for the shareholders and directors beneficial owners;
- Document background of Co., Assets, liabilities;
- Is it trading etc. etc. Higher risk
- Has it been an auditor to the Co. in last 12 months;
- If audit exempt Ethical Standard Part D If material relationship in last 3 years Consider if appropriate
- Interview with directors See engagement acceptance checklist
- Assess risk
- Obtain indemnity from shareholders



On Appointment (Page 17)

- Ensure From E2 filed with CRO within 14 days (Category 4 offence if not) S.592 CA
- Place add in Iris Oifiguil 14 days from resolution;
- Insurance
- If vatable assets register for VAT liquidator required to register personally
- Takes time to get VAT number What to do?
- Confirm liabilities, debtors, obtain stock details;
- Issue appointment letters to those affected banks, solicitors
- Arrange for separate bank account for liquidation 'XXX Limited (in Voluntary Liquidation'), Name, Liquidator



During the Liquidation

- Arrange for pre-liquidation tax returns to be submitted; Get Revenue clearance
- Watch CT1 return deadline within 3 mths;
- Brings forward preliminary tax;
- Does not prevent close Co. Surcharge;
- Group CGT relief is broken not loss relief



During the Liquidation

- Realise assets/ pay liabilities;
- If trading extra work required
- Distributions Approved by members before payment notice of meeting;
- Before distribution Letters have indemnity & make clear S/H gets own tax advise
- Distribution in specie Watch loss/dilution of retirement relief if trade assets distributed How to get over this??
- Distribution in specie investments/receivables
- Assess if VAT to be charged VAT on property (restrictions on option tax);
- CGT implications on disposal of chargeable assets;
- Section 400 cannot apply in liquidation cases
- Ensure CG50 requirements are met
- Date of distribution taken as part disposal of shares



During the Liquidation

- Part payment of fees S.647(2)(C) approved by members; = SOIP 9B
- Agreed of final fees Section 646(2)(c) approved by members; = SOIP 9B
- For groups have separate bank accounts
- Arrange for post liquidation CT1 and CGT returns (if development land) to be filed up to date of closing meeting;



Completions (P.32)

- Review of SOA versus actual. Ensure all assets/liabilities settled;
- Confirm revenue clearance and de-register taxes
- If goes over 12 months
 - Arrange for general meeting <=28 days after year anniversary submit to CRO within 7 days of meeting – Form E3
 - Form E4 details of the proceedings file within 14 days & this done every 6 mths



Completions

- Final meeting 28 days notice general meeting;
- Account of liquidation;
- Approve fees
- Arrange for procedures for books and records liquidator required to hold for 6 years – Special resolution
- File Form E5 Statement of account (S.705) S7B SOIP
 - Detail fees without disbursements;
 - Notes for distribution in specie
 - SOA's vs actual
 - Separate line item for trading while in liquidation;
 - Fee paid to practitioners own firm shown separately & fees paid for professional advise shown separately
- File Form E6 Confirmation of final winding up meeting (S.705)



Conclusion

- Plan in advance of liquidation;
- Remember reliefs in liquidation cases are concessions;
- Maintain the checklist;
- Have dates tracker;

E) Conclude whether it is realistic to assume that the company will be able to pay all its creditors,	

including liquidation expenses, within twelve months.	
F) Where parent company (or other) support is required to achieve solvency, ensure proposed form of support – undertaking, upfront/deferred funding, etc – is acceptable.	
G) Consider need for indemnities (nature of trade, when trading ceased, terms and conditions, warranties, history of claims, etc) if duty to seek out claims cannot readily be met, or where early distribution is proposed.	
H) Consider whether a bank guarantee/letter of credit/other security is necessary to support any indemnity	
I) Ensure the tax aspects of the proposed liquidation for the company and its shareholders have been fully considered by the company and its advisors, including timing and the implications of any pre-liquidation debt forgiveness/funding steps proposed.	
J) If the company has given security to its bank or otherwise, the holder may enforce the security on liquidation. The company should brief the holder and agree the strategy for dealing with his position.	
K) Consider need for indemnity for costs.	
L) Have we considered the extent of tax work required for the liquidator on appointment and has this been reflected in the fee	
M) Provide a letter of consent to act as liquidator once all acceptance procedures are carried out.

Name of procedure: Summary approval procedure to place a company into members' voluntary liquidation under Section 579

Sectional references: Section 579 of CA 2014 (Procedures for and commencement of members' voluntary winding up); Section 201 & 202 of CA 2014 (Summary Approval Procedure), Section 207 of CA 2014 (declaration to be made in the case of members' winding up of a solvent company); Section 181 (notice of general meetings), Section 193 (unanimous written resolution) & Section 194 (majority written resolution) of CA 2014; Section 208 of CA 2014 (requirement for an independent persons report); S643 CA 2014 (notifications and filings of appointments and removals of liquidators); Section 581 CA 2014 (Publication of resolution to wind up voluntarily); Section 705 CA 2014 (Final meeting and dissolution in members' voluntary winding up); Section 707 (disposal of books and papers of company in winding up); Section 584 CA 2014 (Duty of directors to call Creditor meeting) and Section 596 CA 2014 (Custody of company's property).

A) Steps required to be taken by the directors/shareholders

Step	Commentary	Legislative Reference	Done / Comments	Work done by Reviewed by
1	 There are a number of matters that are typically dealt with before commencement of the liquidation process to ensure the liquidation itself occurs without undue complication. In summary, prior to liquidation, the directors consider addressing the following matters (this is not an exhaustive list): 1. Realise all assets where possible and ensure all liabilities where possible are paid off. For some companies this may mean considering the possibility of forgiving amounts owed to other group companies or converting the liabilities to share capital. However tax advice would need to be obtained on the consequences of same. 			
	2. Close any non-necessary bank accounts.			
	3. Ensure Register of Members etc is up to date.			
	4. Submit all outstanding taxation returns.			
	5. Recognise the need to prepare and submit corporation tax returns and agree the liability from the end of the last accounting period down to the day before the date of commencement of liquidation if applicable.			
	6. File with the Registrar of Companies all documents which the company is by law obliged to file.			

7. Make appropriate arrangements to discharge or to enable the company to discharge (within twelve months of commencement) all of its debts in full.		
8. Where VAT will likely be an irrecoverable cost:-		
i) Make appropriate arrangements for the payment of fees and expenses to be incurred in preparing the pre-liquidation documentation and procedures to put the company into liquidation.		
ii) Make appropriate arrangements for the payment of fees, expenses and outlay to be incurred by the liquidator in conducting the winding up and liquidation of the company to completion and in distributing the assets.		
9. Consider the choice of liquidator.		
10. The directors to ensure that the company is solvent and has the funds to pay all creditors in full and to pay for the liquidation process.		
11. Review loans attached to assets in the company to see if the bank will provide funding to the shareholders to allow the loan in the company to be repaid through a subscription of shares by the shareholder with the proceeds of the shares subscribed for in order to avoid stamp duty when the loan liability is distributed by the liquidator. If this is allowed new shares will have to be subscribed for and the usual process for the allotment of shares should be followed.
