Opportunities in a downturn

Great opportunities at this time if intention was & is still always there:

Ability to transfer shares to family at lower valuation - Less tax exposure - CGT/CAT - less eating into thresholds - family partnerships;

Transfer part shares now & buyback remainder / Transfer house to child with right of residence

Lower valuation - less tax on issuance of shares to Key employees no matter what scheme used;

Growth share scheme - if low value now - can get access to value quicker - two sided sword however;

Share options;

Restricted share schemes


Importance of valuations in any of these schemes


Depending on amount subscribed for shares & class - may be possible to carry out SAP 204 process to reduce share capital & pay back money shareholder - True cash flow measure here in difficult times

Opportunities in a downturn

Use of Company Law to provide funding to cash strapped shareholders:
Carry out a summary approval procedure under Section 202 and 203 Companies Act to loan money — Depends on value of loan
Can be used as stop gap while banks are not lending;
NB — BIK — preferential rates 4% & 13.5%
Sell assets in Co. to shareholders (maybe losses to shelter chargeable gains) — Consider stamp duty
If things go bad — debt restructuring personally by
Selling Property to Co.; or
Selling sole trader business to Co. & claiming relief


