

Recent developments

· Covid-19 – seeing accelerated succession planning: Significant drop in asset values in certain sectors:

- · Commercial property
- Trading companies valued on an earnings basis
- · Negative economic climate · Reduced values = reduced tax
- · Fear of increased capital taxes in the future or a
- wealth tax
- · A lot more Will planning

Retirement relief - main conditions

- Relief from CGT on the disposal of certain business assets
- Investment assets do not qualify for relief
- Individual 55 years of age or above
- Subject to a tax avoidance provision must be a bona fide disposal not to avoid tax

Retirement relief - main conditions

- Two forms of retirement relief, disposal to third party (s598) and disposal to child (s599 – requires a claim)
- €750k lifetime consideration threshold (€500k -66 y.o.a +)
 Relief can be clawed back if proceeds exceed
- €750k/€500k (watch inter-spousal disposals)
- No upper limit on disposals to child for under 66 y.o.a
- Relief is €3m on disposal to child for 66 y.o.a +
- Relief clawed back if child disposes of assets within 6 years CGT paid by child

Retirement relief -recent TAC case

- · Case 140 TACD 2020
- · Covered the interaction of s598 and s599
- Asset disposed of to child relief availed of under s598
- Asset sold within 6 years by child
- Revenue contended that relief was claimed under s599 due to ticking the "within the family" box on Form 11
 Result = clawback of CGT on the child
- TAC held that taxpayer availed of relief under s598
- TAC if clawback arose under s599 that s598 would then have applied to negate it

Retirement relief - sole trade type asset

- Must be non-investment asset e.g. farm or a shop
- Held at least 10 years
- Used for trade etc throughout the 10 years up to disposal
 Goodwill
- Qualifies on non-connected sales
- Bona fide test on sale to connected company
- "Reasonable to consider" no tax avoidance motive for sale
- Interspousal transfer and subsequent claim for RR?
 Lifetime transfer only period of ownership transfers
- On death period of ownership and period of use transfer
 Leased farm land see Revenue Operational Manual
- 19.06.03
 TAC shares in a milk co-op for dairy farmer?

Retirement relief - recent TAC case

- · Case 156 TACD 2020
- · Retirement relief claimed on land let on "conacre"
- $^\circ$ Land had been let for a good number of years and disposed of to $3^{\rm rd}$ party in 2017
- Conacre found not to be farming
- Appellant failed to provide evidence that she used the land for the purposes of farming
- Relief denied

Retirement relief - shares in a company

- Must be a family company decided by voting rights
 25% of voting rights, or
- Not less than 10% with family holding not less than 75%
- Shares held at least 10 years
- · Director at least 10 years with at least 5 years FT working
- · Interspousal transfer and subsequent claim for RR?
- · Lifetime transfer only period of ownership transfers
- On death period of ownership and directorship transfer
 Company must be wholly or mainly trading throughout 10 years
- Using the work of the second sec
- Wholly of mainly test look at it in the round
 Investment assets water down the relief available

Retirement relief - shares in a company

- · Company must be wholly or mainly trading?
- Look at it in the round!
- What are the tests (non-legislative)?
 - Income from non-trading activities;
- The asset base of the company;
- Expenses incurred, or time spent, by directors/employees;
- The company's history;
- Balance of indicators what else is indicative?
- No one test is conclusive
- Exceptional cases can be difficult e.g. personal service companies with large investment assets

- Once wholly or mainly trading is established, what then?
- Look at the impact of investment assets on retirement relief
- · Formula for calculating level of relief available

Retirement relief - FA 2017 changes

- · FA 2017 changes:
- · Disposal to connected company now subject to bona fide test
- "Reasonable to consider" bona fide disposal not for tax avoidance
- RR to 3rd parties and RR to child can now aggregate where:
 Parent makes a disposal of shares to child, and
 - Makes a disposal of shares to a company controlled by that child, and
 - The parent is 66 years of age or above
 Effect of this provision is to potentially exceed the RR to 3rd parties
 - Instantial of €500k (66 YOA)
 This gives rise to a charge to CGT or a clawback of the relief
 - Impact on share buybacks?

Retirement relief - FA 2017 changes

Example

- Tom (55 y.o.a) owns 100% of the share capital of Company A
- Tom and Company A satisfy the conditions for RR
- Tom sells his shares in Company A to his son's company, Company B, for ${\in}700k$
- Post the sale Tom is still connected to Company A
- Does he qualify for RR?
- Position is now uncertain
- Sale must be bona fide and not for tax avoidance
- Aside from this big question now is IT or CGT following FA 2017 changes to s135 TCA

Retirement relief - FA 2017 changes

Example

- $^\circ$ Tom owns 100% of the share capital of Company A, it is valued at ${\in}1{\rm m}$
- Tom is 66 YOA
- Tom and Company A satisfy the conditions for RR
- Tom gifts €500k of his shares in Company A to his son avails of RR on disposal to child s599
- Tom sells the balance of his shares in Company A to his son's company, Company B, for €500k
- For the purposes of 3rd party RR Tom's proceeds from sale aggregate with the gift – total €1m
- Result is that €500k RR threshold breached and no RR on disposal to Company B
- · RR still available on gift could ER apply to soften the blow?

Retirement relief - Example 1

- Paul is 54 YOA, he holds 100% of the shares in his trading company P Ltd
- P Ltd is worth say €1.5m
- Paul's wife has been a director of P Ltd for at least 10 yrs and worked on a full time basis for at least 5 yrs
- Paul wishes to liquidate P Ltd in the coming yrs and maximise the RR available
- Paul should transfer 50% of the shares to his wife before reaching 55 aggregates from 55 onwards
- Period of directorship does not transfer with gift of shares to spouse not needed she was a FT director
- Period of ownership does transfer
- Result is tax free €1.5m from company rather than €750k

Retirement relief – Example 2

- · Simon was 70 YOA, he held the entire share capital of S Ltd
- S Ltd was worth say €400k
- Simon held the shares for 10 years and was a full time working director of the company etc
- Simon died and the shares transferred to his spouse Karen
- Karen was appointed as a director when Simon died and ran the company
- She sold it 1 year later for €500k does she qualify for RR?
- Yes on death period of ownership of shares \boldsymbol{and} period of directorship transfer to spouse
- In any event, capital gain only €100k

Example 3 – inter-spousal disposal

- Derek sold his company for €750k two years ago
- Retirement relief was claimed and CGT of €250k was saved
 Derek also has a farm worth €1.2m, he has farmed the land for 10 years
- Derek transfers half the farm to his spouse Karen, what are the tax consequences?
- · No taxes on transfer between spouses, but
- Disposals between spouses aggregate for retirement relief purposes
- Derek regarded as receiving €600k on asset eligible for retirement relief
- Effect earlier relief of €250k clawed back
- · Clawback would also occur if Derek sold land to third party

Example 4 – €3m parent to child cap

- Pat is 66 and holds 100% of a trading company Cup Ltd
- Cup Ltd is worth say €6m (assume no base cost)
- The conditions for retirement relief are satisfied
- Pat wishes to gift shares in the company to his son
 Pat is 66, €3m cap applies = CGT of €990k (€6m-
- €3m)*33% • Early action would have saved €990k!
- Future disposal when 66+ does not aggregate with a disposal pre 66 for the purposes of the €3m cap

Business asset relief – main conditions

- · Applies to gifts/inheritances of qualifying business assets
- Affect of relief is 90% abatement in taxable value of the gift
- Business must be valued at over €3.35m for CAT charge to kick in for child (group A threshold €335k)
- Does not apply to investments assets e.g. rental property (but forestry can qualify – recent Revenue e-Brief)
- · No age requirement unlike retirement relief
- · No relationship requirement
- Assets must have been held by disponer for 2 years for inheritance and 5 years for gift

Business asset relief – main conditions

- For companies control of 25% of voting, or family control or if employee 10% of share capital
- Relief can apply to assets owned personally and used by trading company
- Subject to clawback if recipient makes disposal within 6 years
- Relief also clawed back if business is no longer carried on
- Reinvestment within 1 year can avoid the clawback if business asset is sold
- Can apply to farm assets (perhaps not hobby farm assets though nor to farmhouse)


Excepted/excluded assets and BAR

- Excepted/excluded assets held by a company do not qualify for relief, for example:
 - Rental properties (most)
- Quoted shares
- Assets held by company not used for the business e.g. a boat
- A new business acquired within the 2/5 year hold window
- Expansion organically is ok for relief, expansion by acquisition not so
 Non-working capital cash
- Excess cash is a contentious area how do you prove excess cash is required for the business?

Excepted/excluded assets and BAR

- $\ensuremath{\,^\circ}$ No Revenue guidance on how to determine surplus cash
- Was the cash used for the business?
- Was the cash used to finance the business carried on by the company?
- · How much cash did the company use regularly?
- · What were its short-term cash requirements?
- · Does the amount of cash fluctuate?
- · Cash earmarked for business use can qualify
- Barclays Bank Trust case (UK case) provided a rule of
- thumb that cash = circa 25% of turnover should be ok
- Rule of thumb not tested in Ireland





Succession planning – Example 2

Impact of investment assets on retirement relief for parent
 Formula for calculating level of relief available

Chargeable business assets Total chargeable assets

<u>€200,000 (fixed assets)</u> €400,000 (fixed assets + investment assets)

· Result is that only half of the value of company eligible for relief

CGT liability could be €520k! (assumes ER does not apply)

Succession planning - Example 2

- Solution for CGT in this case would be to convert the investments into non-chargeable assets – e.g. sell the investment for cash/debtor
- Possible to sell to shareholder/connected company and buy back at later date
- Obvious costs would be CGT and stamp duty

Succession planning – Example 2

- Main issue in this case for BAR purposes is the investment assets and excepted assets (excess cash)
- Excess cash is a contentious area how do you prove excess cash is required for the business?
- Often looked at in hindsight as with all audit cases
- In this case assume that €500k is working capital

Succession planning - Example 2

- Lack of full analysis and planning can lead to adverse tax consequences
- · Big problem would actually be funding the liabilities
- In this case tax liability would be circa €520k overall (due to CGT/CAT offset)
- Tax would often be doubled due to the need to withdraw funds from the company to pay the tax (i.e. income tax cost)
- Total tax cost on the transfer circa €1m not a happy client!

Company share buyback

- Excellent opportunity to tax efficiently extract cash from company in non-aggressive fashion
- Normally when company buys back shares = income tax on excess above subscription price
- Share buyback relief allows CGT treatment
- Possible to extract up to €1.5m with retirement relief in some family situations or €2m at 10% with ER
- Most common use is in succession planning
- Much more relevant following FA 2017 changes to s135 TCA distributions

Company share buyback (main conditions)

- The company must be a trading company
- Cant be trading in land, shares etc
- The shareholder must be both resident and ordinarily resident
- The shares must be held for at least five years (some exceptions)
- Buyback must be for the benefit of the company's trade (pre-approval from Revenue??)
- Tax briefing 25 sets out what qualifies –
- Succession planningWithdrawal of equity finance
- Disposal by executors/legatees

Company share buyback (main conditions)

- Expected to resign as a director (unless handing over for short period of time) – recent TAC case
- 3 shareholding/capital tests
- Substantial reduction in shareholding required (25% reduction)
 Shareholder must no longer be connected with the company (30% of capital)
- Revenue want almost complete disposal
- Spouses shareholdings aggregate for the tests
- Company must have adequate distributable reserves
- Company must pay for shares cant be left outstanding

Tax Appeal Commission

- Appeal case no 22 2017 relating to share buybacks
- Taxpayer simultaneously gifted shares and undertook company share buyback
- Not possible for the taxpayer to say accurately what occurred first, the gift or the buyback
- If the buyback occurred first legislative requirements of share buyback would not be satisfied
- Commissioner satisfied that the intention of the taxpayer was to transfer shares to children and dispose of shares
- Found in favour of the taxpayer
- Taxpayer after buyback held 30% of shares and remained on as Chairman no issue

Company share buyback (example)

- Sean and Alison hold 1 share each in the share capital of their company ABC Ltd
- ABC Ltd is worth say €2m
- Sean and Alison wish to transfer the company to their son Sam but also extract say €1.5m
- Sean and Alison to retain some shares (sentimentality)
- Share buyback represents the best way forward
- Steps (broadly):
 - $\,^{\circ}$ Bonus issue of shares to increase share capital say 98 shares
 - Gift of a portion of the shares to Sam 20 shares
 - Buyback say 75 shares
